



## **CONSENT TO RECEIVE AFFORDABLE CONNECTIVITY PROGRAM BENEFIT THROUGH TABLE TOP TELEPHONE COMPANY**

As either a current or new customer of The Table Top Telephone CO, (“Table Top”), by signing below, you have consented to receive broadband Internet access service from Table Top at a discounted rate funded by the federal Affordable Connectivity Program (“ACP”).

In connection with enrolling in the ACP and receiving a reduced rate through Table Top, Table Top notifies you of the following:

- The ACP is a federal government program that reduces your out-of-pocket broadband Internet access service bill. To establish your eligibility for and enroll you in the ACP, Table Top must provide the following information about you to the ACP administrator:
  - your full name;
  - your full residential address;
  - your date of birth;
  - the telephone number associated with your broadband Internet access service;
  - the date on which the ACP discount was initiated;
  - the date on which the ACP discount was terminated (when that occurs);
  - the amount of ACP support being sought for you; and
  - the information that establishes your qualification for the ACP.
- The benefit from the ACP may be applied to only one broadband Internet access service per household.
- If you become ineligible for the ACP, you will be subject to Table Top’s undiscounted rates and general terms and conditions if you continue to receive broadband Internet access service from Table Top. The non-discounted rate for your broadband Internet access service will depend on which broadband plan to which you subscribe.
- You may switch to a different Internet service plan offered by Table Top if you choose.
- You may obtain broadband Internet access service supported by the ACP from any participating provider of your choosing that serves your household.
- You may transfer your ACP benefit to another participating provider that serves your household at any time.

Acknowledgement, Affirmation and Consent by Customer:

By signing below, I acknowledge receipt of the information specified above regarding the ACP. I also affirm I understand that the ACP is a federal government subsidy intended to reduce my broadband Internet access service bill, and if I become ineligible for the ACP, I will be subject to Table Top's undiscounted general rates, terms, and conditions if I continue to subscribe to Table Top's broadband Internet access service. I hereby consent to Table Top providing the information detailed above to the ACP administrator, allowing Table Top to apply the ACP benefit to the broadband Internet access service that I receive from Table Top. I understand that the terms and conditions specified in the Internet Service Agreement with Table Top shall continue to apply during the period in which my bill is reduced by the ACP.
